### SERVICE REQUIREMENT

This Policy does not apply to Two-Wheelers used for hire and reward, or for Two-Wheelers used for any kind of timed competition or race. •Two-Wheelers owned, temporarily or otherwise, by a business formed for the purpose of selling or servicing Two Wheelers are excluded, extended warranty liability, provided that the correct payment has been received, will be subject to the limits indicated on the Registration Form, the extended warranty will only become effective when the Registration Form and payment in full has been accepted by the Warranty Service Provider who reserve the right to decline any extended warranty.
